Retirement Law Changes that may Affect You

2023's new laws include retirement changes, known collectively as "Secure 2.0," that may affect your saving and your giving plans. They may even make it easier for you to make a difference at CMH.

Here are some important things Secure 2.0 does that involve charitable giving:

Increases the required minimum distribution (RMD) age

Secure 2.0 increases the age retirees must begin taking taxable withdrawals to 73 in 2023 and 75 by 2033, up from the previous 72. It does not, however, increase the age an IRA owner can make a qualified charitable distribution. That age remains at $70\frac{1}{2}$.

How does this affect me?

Simply put, the extension of the RMD age gives you more time to save. You will enjoy additional tax-free growth. It also can be significant if you do not want to begin withdrawing retirement funds during an unsettled economic climate, giving you more time for your stock portfolio to recover.

ion Adjusts the annual limit on direct gifts to qualified charities from your IRA

Currently, those 70½ or older can give up to \$100,000 directly from their IRA to a qualified charity without paying income taxes on the distribution. Beginning in 2024, this number will be adjusted annually for inflation.



e. How does this affect me?

The Legacy of Alfred L. Scott February 3, 1931 – June 27, 2022

Alfred L. Scott's affiliation and support of Columbia Memorial Health began in the early 1990's. Al's involvement and leadership grew steadily over the years; he served on the CMH Foundation Board of Trustees from 1999 until 2020 and was then appointed Director Emeritus. During his tenure, he served as Vice Chair and Chair of the Board.

In 2000, CMH began plans to build and finance many campus improvements as part of the "Fulfilling the Dream" capital campaign. Al stepped forward to join the hospital board, sharing his expertise as a successful business leader. His many personal contributions played a critical role in the success of the campaign which exceeded its \$10 million goal. He served the hospital board admirably until 2008.

Al was honored at the Hospital Ball in 2007 for his leadership and devoted service. In 2023, CMH and the CMH Foundation had the distinct honor to present a plaque to Al's family at a special tribute ceremony. The plaque is displayed in the main lobby of the hospital outside the Public Relations Room.

The legacy of Alfred L. Scott, his wisdom, tenacious fundraising spirit and compassion for others will be remembered by the lives he gracefully touched. Al's gift of time and financial resources will help ensure CMH will continue to deliver the highest quality healthcare for future generations.
