# Beneficiary Designations Simple Ways to Leave Your Legacy

Many people don't realize that retirement plans, IRAs, life insurance, and donor advised funds are not affected by a will. These accounts are dispersed according to beneficiary designations. The forms are often easier to update than a will, making them a simple way to leave your legacy.

#### 1. Retirement Plan or IRA

Typically, this is the largest source of taxable income when paid to a beneficiary. If you are considering a gift to the CMH Foundation, it is usually better to leave taxable assets like retirement plans and give other assets like stocks or real estate to loved ones.

#### 2. Life Insurance

A gift of life insurance is a good way to maximize your impact. By naming CMH Foundation as beneficiary, your small premium payments transform into a sizable gift. Plus, it is revocable at any time if your plans change.

#### 3. Donor Advised Funds

A Donor Advised Fund (DAF) gives you flexibility to recommend how much and how often money is granted to CMH Foundation and other charities. You can transfer cash or other assets to a community foundation, brokerage house or other sponsoring organization, and in return, you qualify for an income tax charitable deduction for gifts to your DAF.

It is very simple to name CMH Foundation as a beneficiary. Start by requesting a change-of-beneficiary form from your policy administrator or download the form from your provider's website. Make your desired changes and return the form to establish your gift.

The CMH Center for Breast Health adopts a leading national model of comprehensive and integrated breast care that improves both quality of care and patient outcomes. Services available at the center include screening and diagnostic 3D mammography; diagnostic ultrasound; ultrasound guided biopsy; and stereotactic breast biopsy. Education on breast health, consultation on treatment decisions, and support groups for patients and their families are also provided.
