Kirk Kneller was appointed to the Columbia Memorial Health Board of Trustees in 2014. He served as treasurer from 2020 to 2022 and board chair from 2022 to 2024. He is currently a member of the Albany Med Health System board as well as the joint board of governors for Albany Medical Center Hospital, Columbia Memorial Health, and Glens Falls Hospital. Mr. Kneller has been the chair of the CMH Hospital Advisory Board since 2024 and has served on committees guiding hospital finance, governance, compensation, audit, staff credentialing, performance improvement, planning, and pensions. He is also a member of the CMH Foundation board of trustees since 2016.

Mr. Kneller has long ties to Columbia County. He is the president of Kneller Insurance Agency, which has locations in Chatham, Valatie, and Copake. He purchased what was then known as the Lofgren Agency, Inc. in 1988. Today, Kneller Insurance Agency is one of the oldest agencies in the county providing a full range of services from property, casualty, home, auto, health, and life insurance coverage. The agency's impact is far reaching, with customers in New York, Connecticut, Massachusetts, Vermont, New Jersey, New Mexico, South Carolina, Florida, and Wyoming.

Mr. Kneller's honor also recognizes his deep devotion to the community. He is a founding member of Columbia County Habitat for Humanity and is a strong supporter of Northern Columbia County Pop Warner Football and the Chatham Gold Track Program. He is also the President of the Chatham Rural Cemetery Association and past President of Chatham Lions Club.

Mr. Kneller and his wife of 44 years, Susan, own and operate Locust Hill Farm, an organic, sustainable cow heirloom breed farm which preserves an endangered species of cattle, the American Milking Devon, and an angus cow-calf operation. They also own Locust Hill Barn, an event space in Ghent. The Knellers are proud parents of Brooke (Scott) Decker, Lauren (John) Merante, and Danny (Maria) Kneller, and have three grandsons, Luca, Weston, and Jackson, and their first granddaughter, Noa Louise.

Aven Kerr joined the Columbia-Greene Hospital Foundation Board in 2002 on the recommendation of Rick McCarthy and served until 2019 when she was appointed director emeritus. Aven was deeply involved, her professional demeanor and business experience stood out and proved to be a foreshadowing of all she would bring to the board.

Aven served in numerous leadership roles including terms as chair, vice chair, president, and secretary. Aven's leadership spanned the successful 2004-2009 "Fulfilling the Dream" capital campaign. The campaign funded many important capital projects including significant renovations to the Intensive Care Unit and the Emergency Department; the purchase of state-of-the-art Medical Imaging equipment; the beautifully redesigned Paul and Clara Kellner Café; renovation of the Hospital's main lobby, 5th and 6th floors; the parking garage and connector to the Medical Office Building; as well as the expansion and renovation of the Hospital laboratory.

Aven was elected to the Hospital Board of Trustees in 2007 where she served as both its secretary and vice chair, as well as chairing the governance and compensation committees. She sat on the performance improvement council, and the finance, audit, and ethics committees. Aven also served on various committees for the Town of Chatham.

Aven was a strong board member, and she provided valuable counsel and support to the hospital board chair during her tenure. She brought an interesting combination of business savvy and very hands-on practical advice. A little-known secret: despite her professional, regal, demeanor, she was fond of gory mysteries!

Aven traveled extensively throughout the US, Europe and Asia with her brother and friends. She had on one occasion met Margaret Thatcher, the prime minister of the UK. Aven enjoyed Christmas and threw a party every year attended by her brother John and friends. She enjoyed renovating and decorating "The Barn", her home in Old Chatham. She was a collector of art, jewelry, and books, and loved to hunt for antiques. She loved classical music and played the piano, and she also loved dogs, especially Pearl, her beloved Jack Russell Terrier.

Aven was a good friend to many; she provided support and the kind of business insight that many would cherish. She brought spirit, kindness, and energy to the boardroom.

Aven will be missed by all who knew her.

Columbia Memorial Health Greene Medical Arts Ambulatory Surgical Center



The new Ambulatory Surgical Center (ASC) will be the only one in the Mid-Hudson region, a viable model that will attract new patients, support recruitment and retention of providers, and significantly enhance the quality of care and services provided to our patients.

The Center will serve the rural counties of Columbia and Greene in upstate New York, a population of over 111,000. The facility will be accessible to residents with proximity to the Thruway I-87 corridor and the CMH Hudson campus.

CMH received the Certificate of Need for the project in 2025; the project timeline is 12 to 24 months, with an estimated completion date in the first quarter of 2027. The ASC construction will include four operating rooms and two procedure suites with support spaces, ample parking, and a newly designed entryway for easy access.

Development of the ASC will allow CMH to recapture outmigration of Columbia and Greene County patients in Orthopedics, Gastroenterology, General Surgery and Ophthalmology, maximizing outpatient care to treat same-day cases close to home. The projected volume for surgical procedures is estimated at over seven thousand annually. In addition to these services, CMH will partner with a local cardiology group to develop a cardiac urgent care center that will offer enhanced care with same-day evaluations for patients with cardiac symptoms.

The ASC will provide cost-effective services and a convenient environment that is less stressful, improving the patient experience and maintaining high quality outcomes.

The goals of this project are to enhance quality, promote local patient access and convenience to services, optimize resource effectiveness and prospects of long-term financial sustainability, and ensure the continuance of the enterprise and provision of healthcare services locally which is vital to the clinical, social, and economic health of the communities served.
