Innovative MRI Technology

CMH unveiled state-of-the-art medical imaging technology in July that provides an enhanced experience for patients. The new Philips Ingenia Ambition 1.5T S advanced MRI machine allows for faster scans, superior image quality, and an immersive audiovisual experience, which helps calm patients and guide them through their exams, potentially reducing anxiety and improving overall comfort. The machine reduces acoustic noise up to 80 percent and incorporates positive, peaceful visuals for patients during scans.

The new MRI suite is the latest addition in the hospital's commitment to providing the highest quality care to the community and keeping pace with the latest advancements in medical technology.

The acquisition of the MRI machine was made possible by a generous \$1 million grant from the HRBT Foundation and our community of donors.

New Tax Law - What it Means to You

Newly signed tax legislation extends (and makes permanent) many current tax provisions and introduces new ones that could influence your charitable giving. We want to make sure you are informed to make the wisest decisions regarding your generosity.

Here are seven important elements of the new law, which takes effect Jan. 1, 2026:

What's staying:

- Income tax brackets: The new law permanently extends the 10%, 12%, 22%, 24%, 35% and 37% tax rates.
- **Higher standard deduction:** Most taxpayers will continue to use the elevated standard deduction \$15,750 for individuals and \$31,500 for married couples filing jointly in 2025. It will be indexed for inflation thereafter.
- **Higher deduction limits for cash gifts:** You can continue to deduct cash gifts to public charities up to 60% of your adjusted gross income (AGI) if you itemize.
- **Higher estate tax exemption:** The federal estate and gift tax exemption will remain high and increase to \$15 million per individual (indexed annually).

What's new in 2026:

- Tax break for non-itemizers: You can deduct up to \$1,000 (individuals) or \$2,000 (married couples) for charitable gifts, even if you do not itemize.
- If you do itemize, there is a new floor on your charitable deduction: The new law adds a minimum charitable contribution rate that requires taxpayers to give at least 0.5% of their AGI to receive a tax benefit for their charitable giving.
- Limitation on charitable deduction for those in the top tax bracket: Under current law, top earners receive a tax benefit of 37 cents for every dollar deducted. In 2026, that benefit will be capped at 35 cents.
